

Terms of Use (ToU) of the KinkMatch Website

Preamble

KinkMatch is a connection platform for adults seeking to offer or find companionship services, event presence, well-being support, or personal companionship in a legal and strictly non-sexual context. The site promotes private and confidential encounters based on respect, freedom of choice, elegance, and discretion.

Prior Warning – Consent and Sensitive Content

By accessing the KinkMatch site, you acknowledge that:

- You are 18 years of age or older and legally able to use this type of service.
- The site may contain images or descriptions that could offend certain individuals.
- You agree to our Terms of Use and Privacy Policy.

If you do not agree, you must leave the site immediately.

1. Acceptance of the Terms

Use of the KinkMatch site constitutes full acceptance of these Terms of Use (ToU) by the user (both companions and visitors). If you do not accept all or part of the ToU, you must leave the site immediately.

2. Access to the Site – Adults Only

Access to the site is strictly reserved for individuals aged 18 or over. KinkMatch reserves the right to suspend any account if the user's age cannot be verified or if it appears to be used by a minor.

3. Nature of the Services Offered

KinkMatch does not offer or promote any sexual or sexually-oriented services. The platform's sole purpose is to facilitate connections between adults for activities such as companionship, event presence, well-being, outings, non-erotic comfort massages, or private company.

4. Posting Ads

Each registered user agrees to:

- Not post any rates, pricing, or financial references.
- Not describe any direct or indirect sexual service.
- Use neutral, respectful, and non-suggestive language.
- Not publish pornographic or sexually explicit images.

- Respect the image, ethics, and legality of the site.

KinkMatch reserves the right to moderate, edit, or remove any non-compliant ad.

5. User Commitments

All users (clients or companions) agree to:

- Respect other members, their boundaries, and their companionship terms.
 - Not solicit or offer sexual or paid services, even in private messages.
 - Use the site in strict compliance with French law.

6. KinkMatch's Responsibility

KinkMatch acts solely as a technical intermediary. The platform is not responsible for users' behavior outside of the site. It has no direct or indirect involvement in real-life encounters.

7. Personal Data & Privacy (GDPR)

KinkMatch collects personal data as part of its operations. In accordance with the General Data Protection Regulation (GDPR), you have the right to access, rectify, delete, or transfer your data upon request to: contact@kinkmatch.eu

This data is securely stored and retained only for the necessary duration for which it was collected. KinkMatch commits to collecting only the data strictly required for the site's operation, including:

- Creating and managing user accounts
- Enabling private communication between members
- Ensuring platform safety (moderation, abuse prevention)
- Improving user experience

8. Account Deletion

KinkMatch may suspend or delete any account violating the ToU, without prior notice, especially in cases of:

- Illegal or explicit content
 - Inappropriate or dangerous behavior
 - Reports by another member

9. Subscription Plans and Access to Premium Features

Access to certain features is reserved for users with an active subscription. Premium features include:

- Uploading additional photos and videos (depending on the plan)
- Access to private messaging (chat)
- Viewing and reporting problematic clients on a blacklist
- Enhanced visibility in search results

Subscription Plans:

- **Basic (Free):** 1 photo, 1 active ad, blacklist access, no chat, no videos
- **Silver (€11.99/month):** Up to 6 photos, 1 active ad, chat access, blacklist, Silver badge
- **Gold (€44.99/month):** Unlimited photos, 1 video, 3 active ads, chat, blacklist, featured ads, story creation, Gold badge
- **Platinum (€99.99/month):** Gold features + 4 active ads, Platinum badge, maximum visibility

Subscriptions are monthly and renew automatically unless canceled before the due date. Payments are processed through a secure third-party provider. No refunds will be issued once the current period is confirmed.

KinkMatch reserves the right to modify subscription rates and features at any time with prior notice.

10. Modification of the ToU

These Terms of Use may be modified at any time. Users will be informed online or by email. Continued use of the site implies acceptance of the changes.

11. Governing Law

These ToU are governed by French law. In the event of a dispute, only French courts shall have jurisdiction.

12. Private Messaging Feature (Chat)

KinkMatch provides a private messaging service to allow users to communicate confidentially. This feature is offered solely to facilitate respectful contact within the bounds of the ToU and applicable laws.

13. Commitments When Using Chat

By using the private messaging system, users agree to:

- Not propose or request sexual services, paid or unpaid

- Not mention or negotiate prices or financial compensation
- Not share sexually explicit, violent, offensive, or discriminatory content
- Respect consent, confidentiality, and courtesy in conversations

Any abuse may result in immediate account deletion.

14. Message Moderation and Liability

KinkMatch is not obligated to actively moderate private conversations but may intervene retrospectively upon report or suspicion of illegal activity. Messages may be temporarily stored for security purposes, in accordance with GDPR, and may be shared with authorities upon judicial request.
